GreyText – A Bibliographic Archive on Grey Literature 2004-2010

(Date of Access, March 2010)

GreyText is a bibliographic archive of documents on grey literature. Some 150 documents are indexed by first author followed by the title, source, date of publication and length in printed pages. Free Access to the first page of each document is available for browsing. Also, in most cases the corresponding PowerPoint is online available.
