TextRelease receives Central Contractor Registration (CCR) Approval_

In October 1993, the U.S. President issued a memorandum that mandated the Government reform its acquisition processes. Subsequently, the Federal Acquisition Streamlining Act (FASA) of 1994 was passed, requiring the establishment of a "single face to industry." To accomplish this, the Department of Defense identified a centralized, electronic registration process known as CCR as the single point of entry for vendors that want to do business with this and subsequently other U.S. government departments and agencies.
